4. **Bylaw 14.3.5.4- Advanced Placement- 9/18/92 Interpretation**  
Sarah Wilhelmi, West Coast Conference, indicated that her conference has been working on an issue with the NCAA staff regarding advanced placement credits for incoming international student-athletes. Wilhelmi expressed frustration with this matter because the language in the 9/18/92 interpretation is not very clear and is not consistent with an interpretation one of her schools received a few years back on a similar matter. Wilhelmi asked for feedback and whether anyone else has worked with this bylaw and/or interpretation. No one on the call has worked on case like this before, and the group agreed to have D'Antonio contact the NCAA staff about how to proceed.
5. **Academic Cabinet / two-year college transfer requirements**  
D'Antonio referenced the attachment that included an NCAA memo and document regarding academic reform efforts for two-year college transfer requirements. Specifically, the CCACA is one of a few constituency groups being requested to provide feedback to the NCAA. After reviewing the requested due dates, D'Antonio suggested inviting Geoff Silver, Jennifer Strawley and/or Diane Dickman, NCAA, to the in-person meeting so the group can provide feedback at that time. The group agreed that this would be a good topic for the second day of the meeting in January.
